RURAL GOVERNMENT ORDINANCE (Cap. 132)

KOTA BELUD (TAMU) BY-LAWS, 1954 (G.N.S 99 of 1961)

1.	These by-laws may be cited as the Kota Belud (Tamu) By-laws, 1954 and shall apply to the Kota Belud Tamı
	Ground and such other Tamu grounds as the Local Authority shall direct.

2.	In t	hese	By-	laws	_

"Tamu" shall mean the Kota Belud Tamu Ground as delineated on Survey Department Plan No. 7776 as Survey Lot No. 2192, Mukim of Kota Belud and any tamu established by the Local Authority within the local area.

- No person shall sell any commodity in any tamu without a licence which may be issued by the President or the Deputy President of the Local Authority in his discretion, and subject to such conditions as he may see fit to impose.
- 4. Any person whose application for a licence has been refused may appeal to the Local Authority at its next meeting, and such decision of the Local Authority decision shall be final.
- 5. The following fees shall be paid for licences under by-law 3 [Sub. G.N.L 41/64, G.N.L 13/85] —

KOTA	Ringgit				
(a)	for a licence to sell from a sulap, cloth and general merchandise of all kinds not being of local manufacture	18.00 per month			
(b)	for a licence to sell from a sulap any food or drink for immediate consumption	18.00 per month			
(c)	for a licence to sell cloth and general merchandise of all kinds not being of local manufacture otherwise than from a stall	5.00 per month			
(d)	for any other licence	1.00 per day			
ANY OTHER TAMU					
Half the fees set out above.					

- 6. The Local Authority shall appoint any person to be a Tamu Master who shall be charged with the keeping of order in and the general management of the tamu.
- 7. Any licensee who shall fail to comply with any direction given by the Tamu Master within the scope of his authority shall be guilty of an offence within the scope of his authority shall be guilty of an offence against these By-laws.
- 8. Any person who-
 - (a) sells any commodity in any tamu without a licence issued under these By-laws; or
 - (b) takes or attempts to take into any tamu any intoxicating liquor; or

- (c) has in his possession in any tamu any firework, firearm, or any offensive weapon; or
- (d) being a licensee fails to comply with any lawful direction given by the Tamu Master, shall be guilty of an offence against these By-laws and shall be liable to a fine of twenty-five ringgit or one month's imprisonment. [Mod. Act 160]
