# KUDAT TOWN BOARD (TAMU) BY-LAWS 1961 (G.N.S 61 of 1961)

In exercise of the powers conferred upon it by subsection (1) section 15 of the Rural Government Ordinance, and all other powers thereunto it enabling the Kudat District Council has made the following by-laws:

# Title and application.

1. These by-laws may be cited as the Kudat Town Board (Tamu) By-laws 1961 and shall apply to all tamu within the local area of the Kudat Town Board.

# Interpretation.

2. In these By-laws —

"tamu" shall mean the open-air markets established by the Kudat Town Board at the following places —

Mattunggong Tamu Ground

Tigaman Tamu Ground

Bandau Tamu Ground

### Licence.

3. No person shall sell any commodity specified in by-law 5 below in any tamu without a licence which may be issued by the Chairman or the Vice-Chairman of the Town Board in his discretion, and subject to such conditions as he may see fit to impose. No licence is required for other items of local manufacture.

# Appeal.

**4.** Any person whose application for a licence has been refused may appeal to the Town Board at its next meeting, and the decision of the Town Board shall be final.

#### Fees.

5. The following fees shall be payable for licences issued under by-law 3 —

per month

(a) for a licence to sell cloth and general merchandise of all kinds not being of local manufacture ... ... ...

(b) for a licence to sell locally grown tobacco and locally produced cooked foods ... ... ... ... ...

# Tamu Master.

**6.** The Town Board may appoint any person to be a Tamu Master for any tamu, who shall be charged with the keeping of order in and the general management of the tamu.

### Penalty.

- **7.** Any person who
  - (a) sells any commodity specified in by-law 5 in any tamu without a licence issued under these By-laws; or

- (b) takes or attempts to take into any tamu any intoxicating liquor; or
- (c) has in his possession in any tamu any firework, firearm or any offensive weapon; or
- (d) being a licensee fails to comply with any lawful direction of the Tamu Master,

shall be guilty of an offence against these By-laws and shall liable to a fine not exceeding twenty-five ringgit or one month's imprisonment.

### Revocation.

**8.** The West Coast Residency Tamu By-laws 1953 is revoked in their application to Kudat District.
