THE LOCAL GOVERNMENT ORDINANCE, 1961 (Ordinance No. 11 of 1961)

LABUAN TOWN BOARD (HAIRDRESSERS) BY-LAWS, 1968

In exercise of the powers conferred upon it by section 50 of the Local Government Ordinance, 1961 [Ord. No. 11 of 1961.], the Labuan Town Board (hereinafter referred to as the Board) has made the following By-laws:-

Title and commencement.

1. These By-laws may be cited as the Labuan Town Board (Hairdressers) By-laws, 1968, and shall come into operation on the 1st day of July, 1968.

Licence for hairdressing.

2. No person shall carry on the business of hairdressing except in accordance with a licence granted by the Board.

Grant of licence.

3. The Board may, in its absolute discretion, grant or refuse a licence, or grant a licence subject to such conditions as it thinks fit. Such licence shall be in the form of the First Schedule to the By-laws.

Health certificate.

- **4.** An application for a licence or for a renewal thereof shall forward a certificate of health in the form of the Second Schedule hereto from a Government Medical Officer or registered medical practitioner. Such certificate shall be endorsed by the Government Medical Officer or a registered medical practioner annually or more often, if so required by the Board.
- (2) All persons engaged in hairdressing or upon the licensee's premises shall likewise produce Health Certificates in the manner set out in By-law 4 (1).

Duration of licence.

5. Every licence granted under these By-laws shall expire on the 31st day of December of the year in which it is granted.

Fee.

6. The following fees are payable for licences :

Premises.

7. No premises shall be used for hairdressing unless the construction, lighting, ventilation, drainage, sanitation, water supply and equipment are adequate to the satisfaction of the Board.

Disease.

8. No person suffering from any contagious or infectious disease shall be engaged in hairdressing.

Customers with disease of hair or skin to be refused.

9. Persons suffering from any disease of the hair or skin shall be refused service.

Provision.

- **10.** (1) A licence shall provide on his premises :—
 - (a) suitable covered containers for the deposit of cut hair and refuse;
 - (b) suitable containers for boiling and sterilizing towels;
 - (c) wash basins and soap; and
 - (d) sterilizing facilities for towels, combs, brushes, clippers, razors and other equipment.
- (2) Every customer shall be provided with a fresh clean towel.
- (3) Only powder sprayers are permitted and the use of powder puffs is strictly prohibited.
- (4) All combs and brushes shall be washed daily in strong disinfectant.

Premises to be kept clean.

11. A licensee shall keep his premises clean and shall comply with such direction as may be given by an officer of the Board for the purpose of preserving cleanliness and order on the licensed premises.

Penalty.

12. Any person who contravenes any of the provisions of these By-laws shall be guilty of an offence and shall be liable to a fine of five hundred dollars.

Cancellation of licence.

- 13. The Board may cancel or suspend a licence :—
 - (a) if the licensee or any assistant of the licensee is convicted of any offence under these By-laws; or
 - (b) if, on the certificate of a Government Medical Officer or a registered medical practitioner, the licensee is suffering from a contagious or infectious disease; or
 - (c) if, on the certificate of a Government Medical Officer the premises are a danger to public health.

Repeal and Replacement. [See L. 20/68.]

14. Part IX of the Labuan Town Board (General) By-laws 1957 is repealed.
