# LOCAL GOVERNMENT ORDINANCE 1961 (No. 11 of 1961)

# LABUK/SUGUT DISTRICT COUNCIL (TAMU) BY-LAWS 1975 (G.N.L 17 of 1975)

In exercise of the powers conferred upon it by section 50 of the Local Government Ordinance 1961, the Labuk/Sugut District Council has made the following by-laws:

## 1. Title and application.

These by-laws may be cited as the Labuk/Sugut District (Tamu) By-laws 1975 and shall apply to all tamu established in the Labuk/ Sugut District Council area.

### 2. Interpretation.

In these By-laws —

"tamu" means an open-air or partly sheltered market established by the Council.

#### 3. Licence.

No person shall sell any commodity in any tamu without a licence which may be issued by the Executive Officer in his discretion, and subject to such conditions as he may see fit to impose.

#### 4. Appeal.

Any person whose application for a licence has been refused may appeal to the Council at its next meeting and the decision of the Council shall be final.

#### 5. Fees.

The following fees shall be paid for licences issued under by-law 4 above —

(a)	for a licence to sell from a stall, cloth and general merchandise of all kinds not being of local manufacture	10.00
(b)	for a licence to sell otherwise than from a stall, cloth and general merchandise of all kinds not being of local manufacture	5.00
(c)	for a licence to sell otherwise than from a stall, fruit, vegetable, dried or fresh fish, betel-nut, salt, cakes and other local products	2.00
(d)	for a licence to sell any other commodity	5.00

#### 6. Tamu Master.

The Council may appoint any person to be Tamu Master for any tamu, who shall be charged with the keeping of order in and the general management of the tamu.

#### **7. Penalty.** [Mod. Act 160.]

Any person who —

- (a) sells any commodity in any tamu without a licence issued under these By-laws; or
- (b) takes or attempts to take into any tamu any intoxicating liquor; or
- (c) has in his possession in any tamu any firework, firearm or offensive weapon; or
- (d) being a licence holder, fails to comply with any lawful direction of the Tamu Master,

shall be guilty of an offence against these By-laws and shall on conviction be liable to a fine not exceeding twenty-five ringgit and on a second or subsequent conviction to a fine not exceeding fifty ringgit.
