PUBLIC HEALTH ORDINANCE 1960 (No. 7 of 1960)

SANDAKAN MUNICIPAL COUNCIL (OFFENSIVE AND DANGEROUS TRADES) BY-LAWS 1985 (G.N.L 18 of 1985)

In exercise of the powers conferred upon it by sections 109 of the Public Health Ordinance 1960, the Sandakan Municipal Council has made the following by-laws:

1. Citation and commencement.

These by-laws may be cited as the Sandakan Municipal Council (Offensive and Dangerous Trades) By-laws 1985 and shall be deemed to have come into operation on the 1st day of April 1982.

2. List of offensive and dangerous trades.

(1) The following shall be deemed to be offensive trades:

candle-making dyeing fish-curing foundaries and smithies oil-boiling tallow-melting tanning boat-making vehicle workshop aerated water factory bottled drink factory zinc or metal sheet bone-boiling animal-boiling manufacturers of starch, glue, leather, chemical, fertilizers and gas prawns factory engine repairs (of any kind)

(2) The following shall be deemed to be dangerous trades:

cinemas match factories distilleries and breweries retreading of tyres

3. Licensing of offensive or dangerous trades.

- (1) No offensive or dangerous trades shall be permitted within the Council area except with a licence from the Council and on the conditions hereinafter set out.
- (2) For every licence the following fee shall be charged per month:

4. Construction, drainage, etc..

No building shall be licensed for use in any offensive or dangerous trade unless the situation, construction, drainage and water supply are satisfactory and proper in the opinion of the Council.

5. Exhibition of licence.

Every owner or occupier of premises licensed for use in an offensive or dangerous trade shall exhibit his licence at all times in a conspicuous place so as to be visible to every person entering the premises.

6. Cleanliness.

All premises licensed for use in an offensive or dangerous trade shall be kept clean and wholesome so as not to be offensive or prejudicial to public health.

7. Articles near dwelling-house.

No articles in the process of being used for any trade of an offensive nature shall be spread or hung up to dry in any place within 15 yards of any dwelling-house.

8. Storage of offensive or dangerous materials.

Every person carrying on any offensive or dangerous trade shall cause all materials which have been received upon the premises where his trade is carried on, and which are not immediately required for use, to be stored in such a manner and in such a situation as to prevent the emission of noxious or injurious effluvia therefrom or other risks.

9. Removal of refuse.

All refuse from the process of carrying on any offensive trade, and all fat, offal and other offensive matter shall be removed, if so required, from the premises daily, and deposited in such place as may be approved by the Council.

10. Revocation. [G.N.S 121/55.]

"Part VI – Offensive or Dangerous Trades" of the Sandakan Municipal Council (General) By-laws 1955 is hereby revoked.
