THE LOCAL AUTHORITY (ASSIGNMENT OF FUNCTIONS: THE PROVISIONS OF PARKING PLACES AND STANDS) ORDER 1973

SANDAKAN MUNICIPAL COUNCIL (PROVISION OF PARKING PLACES)(COUPON PARKING) BY-LAWS 2017

In exercise of the power conferred upon it by the Local Authority (Assignment of Functions: The Provisions of Parking Places and Stands) Order 1973 and in exercise of the power conferred upon it by Section 50 of the Local Government Ordinance 1961, the Sandakan Municipal Council has made the following By-Laws:

Citation and commencement

1. These By-Laws may be cited as the Sandakan Municipal Council (Provision of Parking Places)(Coupon Parking) By-Laws 2017 and shall come into force on the date of its publication in the Gazette [2 November 2017].

Interpretation

2. In these By-Laws, unless the context otherwise requires -

"Council" means the Sandakan Municipal Council;

"commercial vehicle" shall have the same meaning assigned to it in the Commercial Vehicles Licensing Board Act 1987 [Act 334];

"controlled period" means the period as specified in the 4th column of the First Schedule during which the parking of a motor vehicle in any parking lot other than a reserved parking lot is subject to payment of the parking fees as prescribed by the Council;

"half hour" includes part of a half hour;

"hour" includes part of an hour;

"motorcycle" means motor vehicles with less than four wheels, and the un laden weight of which does not exceed four hundred and fifty kilogrammes;

"motor vehicle" shall have the meaning assigned to it in the Road Transport Act 1987 [Act 333];

"Ordinance" means the Local Government Ordinance 1961;

"parallel parking lot" means a parking lot in a public parking place which is marked out for the parking of a motor vehicle parallel with and close to the edge of the road;

"park" or "parking" means the bringing of a motor vehicle to a stationary position;

"parking warden" means any person appointed under By-law 16 and includes a person duly authorized by or on behalf of the Council to manage, supervise, and to attend to any public parking place or to carry out any act under these By-laws;

"parking coupon" or "coupon" means a coupon or any document issued by the Council to any person for the purpose of parking a motor vehicle in accordance with By-law 8 and includes a reserved parking permit;

"parking lot" means the space marked out in a public parking place for the parking of a motor vehicle;

"parking place" means place designated for the parking of any motor vehicle; "public parking place" means any road or place as specified by the Council, in which the parking of a motor vehicle is permitted by the Council;

"person" means any individual and includes any company, association, society, body of persons corporate or unincorporated;

"prescribed fee" means the parking fee as prescribed by the Council and payable by any person who parks a motor vehicle in a public parking place; "reserved parking lot" mean a parking lot reserved by the council for the exclusive use of any person;

"reserved parking permit" means an approval granted by the Council to any person for the purpose of parking a motor vehicle in a reserved parking lot in accordance with By-law 25(1);

"road" shall have the same meaning assigned to it in the Road Transport Act 1987 [Act 333];

"sign" includes all notices, instructions, directions signals, markings, warning signs, direction signs and other devices displayed for the guidance or direction of any person driving a motor vehicle;

"seasonal parking" means any of the parking place, specified in the First Schedule to these By-laws wherein any motor vehicle in respect of which seasonal permit has been purchased;

"seasonal parking coupon" means the official document issued by the Council showing the registration number of a motor vehicle and the amount of the prescribed charge for the parking of such motor vehicle in a specified seasonal parking place for a valid period and upon such conditions as the Council may deem fit to impose;

"unregistered motor vehicle" means any motor vehicle other than a motor vehicle which is duly registered in accordance with Road Transport Act 1987 [Act 333];

Power to provide for public parking places

- **3.** (1) The Council hereby provides that the roads or places within the Council's jurisdiction as specified in Schedule 1 of this By-law shall be parking places for motor vehicles.
- (2) The Council may reserve or designate from time to time any parking place or parking lot as specified by the Council for the parking of any class of motor vehicles or the exclusive use of any class of persons for any duration as the Council may determine.

(3) The Council shall have the right to impose charge at the amount as prescribed by the Council.

Parking lot

4. A public parking place may be divided into parking lots and for the purpose of determining the parking lots, the Council may cause each parking lot to be marked out by painted lines, studs, signs or other indications.

Parking without the display of valid parking coupon

- **5.** No person shall park or cause to be parked any motor vehicle in any parking lot without displaying -
 - (a) a valid parking coupon as specified by the Council as may be appropriate during the controlled period; or
 - (b) a reserved parking permit as specified by the Council in respect of a motor vehicle parked in a reserved parking lot.

Controlled period

6. The controlled period shall be such as specified in the 4th column of the First Schedule.

Parking fees

7. The parking fees shall be such as prescribed by the Council.

Issuance of coupons

8. A parking warden or any officer duly authorized by the Council may issue to a person any parking coupon as specified by as may be appropriate upon payment of the parking fees prescribed by the Council.

Irregular and invalid coupon

- **9.** (1) No person shall display or permit to be displayed on a motor vehicle any invalid parking coupon.
 - (2) A parking coupon shall not be valid if -
 - (a) the parking coupon is so torn, defaced or mutilated that the figures or other particulars therein are not legible;
 - (b) the parking coupon contains any alteration, erasure or other irregularity therein which indicates that the coupon has been tampered with;
 - (c) the period of validity of the parking coupon has expired;
 - (d) the parking coupon as prescribed by the Council does not indicate the date and time of commencement of parking in accordance with By-law 10(2); or
 - (e) the value of a parking coupon or the aggregate value of a combination of two or more coupons as prescribed by the Council is insufficient to meet the fee as prescribed by the Council for the period during which the motor vehicle is parked in the public parking place.

Manner of displaying coupon

- **10.** (1) Any person who parks a motor vehicle in a public parking place shall display one or more coupons as prescribed by the Council as may be appropriate on the dashboard of the motor vehicle and in such a manner that the entire coupon is clearly visible for inspection at all times from outside the motor vehicle.
- (2) The date and time of commencement of parking a motor vehicle in a public parking place shall, where required to be indicated in the coupon under these By-

laws, be indicated in the coupon in accordance with the instruction printed on the coupon and be visible for inspection at all times from outside the motor vehicle.

- (3) No person shall display or permit to be displayed on a motor vehicle a parking coupon as prescribed by the Council in which the time of commencement of parking indicated therein is later than the actual time when he parks the said motor vehicle.
- (4) Where two or more coupons as prescribed by the Council are displayed on a motor vehicle to cover the period during the which such motor vehicle is parked in a public parking place, the time of commencement of parking indicated in the second and subsequent coupon or coupons shall run immediately after the expiry of the period of parking indicated in the coupon of the prior period of parking.
- (5) No person shall continue to park or cause to be parked any motor vehicle in a public parking place after the expiry of the period in respect of which the coupons are displayed on the motor vehicle to meet the prescribed fee.

Conditions in parking coupon

11. Any person using a parking coupon shall comply with all the conditions stated therein.

Refund of unused coupons

12. No refund shall be allowed for any unused coupon except in such special circumstances as the Council may allow and provided that the coupons are not defaced, mutilated or in any other manner invalid.

Production of parking coupon

13. (1) A parking warden or any officer authorized by the Council may for the purpose of these By-laws require any driver of a motor vehicle parked in any public parking place to produce for inspection any parking coupon or coupons displayed on such motor vehicle and may retain any such parking coupon.

(2) Upon such request, the driver of the motor vehicle shall produce the parking coupon or coupons displayed for inspection or retention by the parking attendant or any officer authorized by the Council.

Exemption from payment of fees

- **14.** (1) The Council may exempt any class of persons or motor vehicles from payment of the prescribed fee as the Council deems fit.
- (2) The exemption from the payment of prescribed fee in respect of any class of persons or motor vehicles under By-law 14(1) may be withdrawn at any time by the Council.

Restriction

- **15**. (1) No person shall at any time park or cause to be parked any motor vehicle at any place within the Council's jurisdiction except in a parking place approved by the Council for the parking of such motor vehicle.
- (2) No person shall park or cause to be parked any motor vehicle of such size and dimensions exceeding that of the parking lot without the prior written approval of the Council.
- (3) No person shall park or cause to be parked any motor vehicle in a public parking place where the sign indicates that such a public parking place is for the use of a certain class of persons or motor vehicles, unless such person or motor vehicle belongs to that class.

Parking Warden

16. The Council may appoint one or more parking warden to be on duty at any public parking place.

Compliance with directions

17. Any person driving or parking a motor vehicle in a public parking place shall comply with all directions given to him by the parking warden or any officer duly authorized by the Council.

Compliance with conditions

18. The Council may impose any condition as the Council deems fit in managing such public parking places and such condition shall be observed and complied with by every person using the public parking places provided.

Provision of signs

- **19**. (1) The Council may erect or exhibit at a public parking place any sign as the Council deems appropriate for the following purpose
 - to indicate that the parking lot is reserved or designated for the use of a certain class of person or for the parking of a certain class of motor vehicles;
 - (b) to indicate that the parking of a certain class of motor vehicles is prohibited;
 - (c) to indicate the prescribed fee and maximum parking period permitted; or
 - (d) for any other purpose as the Council may deem necessary.
- (2) Any person driving or parking a motor vehicle within a public parking place shall obey all the signs exhibited therein.

Method of parking

- **20**. (1) Any person who parks a motor vehicle in a public parking place shall park the motor vehicle in the following manner
 - a. the motor vehicle shall be positioned entirely within the parking lot;
 - in any parallel parking lot, the motor vehicle shall be parked facing the same direction as the traffic may lawfully move and shall conform to all signs and directives exhibited in such public parking place; and
 - c. the motor vehicle shall not be parked on or across any line marking the parking lot.

Safety of other motor vehicles

21. No motor vehicle shall be drawn, driven or pushed within a public parking place otherwise than in an orderly and careful manner and with due regard to the safety of other motor vehicles and persons within the public parking place.

Unattended vehicle

22. No motor vehicle in a public parking place shall be left unattended unless it is rendered immovable by the application of brakes or by some other sufficient means.

Parking of commercial vehicle, vehicle with permit or motorcycle

23. No person shall park any commercial vehicle or vehicle with permit or motorcycle in any parking lot which is not designated by the Council for the parking of such commercial vehicle or vehicle with permit or motorcycle.

Suspension of use of a public parking or parking lot

- **24.** (1) Notwithstanding any of the provisions of these By-laws, the Council may at his discretion or on the application of any person suspend the use of any public parking place or parking lot whenever the Council considers such suspension is necessary
 - a. for the purpose of facilitating the movement of traffic or promoting its safety;
 - b. for the purpose of any building operation, demolition, or excavation adjacent to the parking lot or the maintenance, improvement or reconstruction of the parking lot or the laying, erection, alteration or repair in or adjacent to the parking lot of any sewer or of any cable, pipe, main or apparatus of supply of water or electricity or of any telegraphic line;
 - c. for the convenience of occupiers of premises adjacent to the parking lot on any occasion for the removal or delivery of furniture from or to any such premises;
 - d. on any occasion on which it is likely by reason of some special attraction or occasion that any road will be congested or obstructed;
 - e. for the convenience of occupiers of premises adjacent to the parking lot at the time of wedding or funerals or other special occasions;

- f. for the loading and unloading of goods; or
- g. for any other reason or purpose as the Council may deem fit.
- (2). On any such suspension, the Council shall cause to be affixed an appropriate notice at or near the public parking place or parking lot in question, and it shall be unlawful for any person to make use of or park any motor vehicle in such public parking place or parking lot except in relation to the purpose for which the suspension is made.
- (3) Whenever the suspension is made on the application of any person, the Council may issue a suspension order subject to the payment of the charges as prescribed by the Council and such condition deems fit to impose.

Reserved parking lot

- **25.** (1) On the application of any person, the Council may issue a reserved parking permit as prescribed by the Council to the person subject to
 - (a) such conditions as may be specified therein;
 - (b) such parking period as the Council may determine; and
 - (c) payment of the parking fee as prescribed by the Council
- (2) The Council may revoke such permit at any time without assigning any reason thereto.

Motor vehicles exempted

26. The Council may give an exemption to any vehicles belongs to any government departments who carrying out public undertaking.

Unauthorized activity in public parking place

27. No person shall without the prior written approval of the Council within any public parking place —

- (a) make use of a parking lot for any purpose other than for the parking of a motor vehicle;
- (b) repair or permit to be repaired any motor vehicle except in cases where the repair is necessary to enable the motor vehicle to be removed from the public parking place;
- (c) obstruct or place any goods ,objects, material or other things on any parking lot or on any part of a road adjacent to any parking lot;
- (d) use any motor vehicle for the sale of or for promoting the sale of any goods, article or thing whatsoever;
- (e) wash or clean or cause or permit to be washed or cleaned any motor vehicle;
- (f) use any motor vehicle for the conduct of driving lessons or training ;or
- (g) carry out or conduct any business or activity or provide any service of whatsoever nature, whether or not for reward.

Obstruction

- **28.** (1) No person shall park any motor vehicle in such a manner as to cause the motor vehicle to protrude into the road adjacent to the parking lot or beyond the boundary line of the parking lot or to obstruct the traffic circulation in the vicinity of such parking lot.
- (2) No person shall in any manner, obstruct or cause any obstruction to a public parking place or any parking lot therein.

Unregistered motor vehicle

29. No person shall park any unregistered motor vehicle in any public parking place without the prior written approval of the Council.

Solicitation for employment

30. (1) No person shall solicit employment as a watchman at a public parking place or for a parked motor vehicle.

(2) No person shall loiter at or near a public parking place for the purpose of obtaining employment as a watchman for a parked motor vehicle.

Emergency

31. In the case of any emergency, any officer authorized by the Council, may remove or cause to be removed to any place as he thinks fit any motor vehicle left in a public parking place.

Prohibition

- 32. No person shall -
 - (a) park or cause to be parked any motor vehicle in contravention of any of the provisions of these By-Laws; or
 - (b) park or leave any motor vehicle in any parking lot for more than two continuous days.

Power of arrest

- **33.** (1) The Council or any officer duly authorized by the Council may arrest without warrant any person who commits in his presence or whom he reasonably believes to have committed any offence under these By-laws -
 - (a) if the name or address of the person is unknown to him and the person declines to give his name and address; or
 - (b) if there is reason to doubt the accuracy of his name or address.
- (2) A person arrested under these By-laws shall be detained and shall be brought before a Magistrate's Court within twenty-four hours unless his name and address are sooner ascertained.

Power of seizure and forfeiture

34. (1) If the Council or any officer duly authorized by Council has reason to believe that any person has committed an offence under these By-Laws, such officer

may seize and detain any motor vehicle, item, tool, instrument, machinery, equipment or other thing whatsoever used or reasonably suspected of having been used in the commission of an offence.

- (2) All motor vehicles, items, tools, instruments, machinery, equipment or other things whatsoever liable to seizure under these By-laws shall be liable to forfeiture provided that the Council or any officer duly authorized by the Council may temporarily release such motor vehicle, item, tool, instrument, machinery, equipment or other thing to the owner of the same on security being furnished to his satisfaction that such motor vehicle, item, tool, instrument, machinery, equipment or other thing shall be surrendered to him on demand or to produce it before a Court of competent jurisdiction provided further that if there be no prosecution with regard to anything seized under these By-laws, such motor vehicle item, tool, instrument, machinery, equipment or other thing shall be taken and deemed to be forfeited at the expiration of one calendar month from the date of seizure unless claim thereto is made before the date.
- (3) Any person asserting that he is the owner of any motor vehicle, goods or thing liable to forfeiture under By-law 35(2) and that it is not liable to forfeiture may personally or by his agent authorized in writing give written notice to the Council that he claim the same provided that any such application shall be made before the expiration of one calendar month from the date of seizure.
- (4) Notwithstanding anything in this sections if anything seized under these Bylaws is subject to speedy and natural decay or deterioration, the Council or any officer duly authorized by the Council may sell the thing and shall thereafter deal with the proceeds of such sale as he would have dealt with such thing had it not been sold.
- (5) All things forfeited shall be delivered to the Council or any officer duly authorized by the Council and shall be sold in accordance with the provisions of the Ordinance or any other law for the time being in force.

Compounding of offences

35. (1) The Council or any officer duly authorized by the Council may compound any offence under these By-laws by collecting from the person reasonably suspected of having committed such an offence a sum not exceeding RM500.00.

(2) On payment of such sum of money, no further proceedings shall be taken against such person in respect of that offence.

Penalty

- **36.** (1) Any person who contravenes any of the provisions of these By-laws shall be guilty of an offence and shall on conviction be liable to a fine of for any one offence the sum not exceeding RM20,000.00 or a term of imprisonment not exceeding 12 months or both such fine and imprisonment.
- (2) In the case of continuing offence, the person shall be liable to a further fine not exceeding RM500.00 for everyday during which the offence is continued after conviction.

Registered owner's liability

37. In case of contravention or failure to comply with any of the provisions of these By-laws, the registered owner of the motor vehicle shall be deemed to have contravened or failed to comply with such provisions if the person (not being the registered owner) who actually contravenes or fails to comply with such provisions is not known or cannot be found.

Council not liable for loss or damage

38. The Council and his officers shall not be liable for any loss or damage to any motor vehicle or the fittings or contents of any motor vehicle parked in any public parking place.

Repeals

- 39. The following By-laws are repealed -
 - (a) Sandakan Municipal Council (Parking Places) By-laws, 1984
 - (b) Sandakan Municipal Council (Parking Places) (amendment) By-laws 2007

Saving and Transition

40. (1) Nothing in these By-Laws shall affect the past operation of, or anything done under the repealed By-laws:

Provided that any right, privilege, proceeding or liability existing at the date of commencement of these By-Laws by virtue of the repealed By-laws, shall be subject to these By-laws.

- (2) Any proceeding, action, claim or liability made, instituted, filed, commenced or incurred under the repealed By-laws prior to the date of commencement of these By-laws, shall be deemed to have been made, instituted, filed, commenced or incurred under these By-laws.
- (3) Nothing in these By-laws shall affect any person's liability to be prosecuted or punished for offences committed, or to be sued for any outstanding parking fees or charges due and payable, by him under the repealed By-laws before the coming into operation of these By-laws.
