### No. 6 of 1968

An Enactment to amend various written laws of the State in order to transfer to the Chief Minister the powers hitherto exercised by the Permanent Secretary to the Chief Minister.

ENACTED by the Legislature of the State of Sabah as follows: -

#### Short title.

1. This Enactment may be cited as the Statute Law Revision Enactment, 1968.

# Amendment of Cap. 23.

2. The Chief Secretary (Incorporation) Ordinance is hereby amended by the deletion of the words "Chief Secretary" wherever they occur and the substitution therefor of the words "Chief Minister".

**3.** The Cinematograph Films (Control) Ordinance is hereby amended by the deletion of the words "Chief Secretary" wherever they occur and the substitution therefor of the words "Chief Minister".

## Amendment of Cap. 161.

- 4. The Liberation Educational Trust Ordinance is hereby amended
  - (a) in subsection (1) of section 4, by the deletion of the words "Chief Secretary" and the substitution therefor of the words "Chief Minister";
  - (b) in section 5, by the deletion of the words "Chief Secretary" and the substitution therefor of the words "Chief Minister".

### Amendment of section 3 of Cap. 167.

5. Section 3 of the Administrative Divisions Ordinance of is hereby amended by the deletion of the words "Chief Secretary" and the substitution therefor of the words "Chief Minister".

  - (a) in paragraph (i) of subsection (1) of section 18, by the deletion of the words "Chief Secretary" and the substitution therefor of the words "Chief Minister";
  - (b) in paragraph (g) of section 21, by the deletion of the words "Chief Secretary" and the substitution therefor of the words "Chief Minister".
